Opening permission for classes I to X (EM) during the academic year 2021-2022 in respect of Delhi Public School, Brahma Nagar, North Rajupalem, Kodavalur Mandal, SPSR Nellore District without aid now or in the future in the orders 7th read above. The Deputy Educational Officer, Nellore, SPSR Nellore District has recommended for Grant of Provisional Recognition for classes VI to X (EM) during the academic year from 2021-2022 to 2023-2024 without aid now or in future vide letter 10th read above. The District Educational Officer, SPSR Nellore District has verified the application for Grant of Provisional Recognition for classes VI to X (EM) during the academic year from 2021-2022 to 2023-2024 without aid now or in the future with reference to the Inspection Report of the Inspecting Officer and also with the reference to the conditions laid down in the permission orders and G.O.Ms.No:1 Edn., (PS-I) Rules Department Dt:1-1-1994 and submitted a report in his letter 11th read above.

After Careful examination of the references read above and the conditions prescribed in G.O.Ms.No: 1 Edn, Date:1-1-1994, G.O.Ms.No.41 Edn, Date: 11-05-2006,

G.O.Ms.No. 74 Education Dt: 11-09-2006 and as per the instructions issued by the Commissioner and Director of School Education, Andhra Pradesh, Hyderabad in the reference 6th cited, the Regional Joint Director of School Education, Guntur is hereby accorded for grant of Provisional Recognition for classes VI to X (EM) during the academic year from 2021-2022 to 2023-2024 without aid now or in future in respect of Delhi Public School, Brahma Nagar, North Rajupalem, Kodavalur Mandal, SPSR Nellore District. However, by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abide by the instructions, rules and regulations made by the Government or authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time
4. The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
5. That the qualified staff within the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the Staff pattern.
6. That the results of the Institutions shall be satisfactory every year.
7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit a proposal for renewal of Extension of Temporary Recognition sufficiently in advance i.e., at least 6 months prior to the date of Expiry of the renewal.
14. The Recognition now given is purely on a temporary basis and is subject to the reports of the State Level Inspection and Vigilance Committee fulfilling all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
15. The Management is requested to follow the instructions of the Fire Department and renew the Fire Certificate from time to time without fail and submit the same to this office through the Deputy Educational Officer, Nellore and District Educational Officer, SPSR Nellore District.
16. The Management is requested to renew the Vehicle Fitness Certificate every year from the concerned authorities without fail and submit the same to the concerned Deputy Educational Officer.

Further, the managing committee of the school is requested to fulfill all requirements to cope with the needs of the institution at the latest before submitting of application for Extension of Temporary Recognition for the year 2024-2025.
